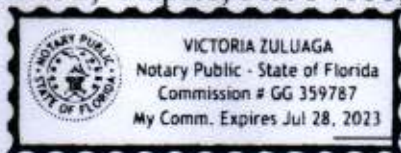
3.) Rick's 15-Florida Counties[¶] are 93-percent superior ^(15/1 % change) to Skinners one-county.
